Frequently Asked Questions

How long are Dr. Wallace's presentations?

Dr. Wallace's keynotes are 45 minutes to 1 hour in length. Her workshops are typically 90 minutes, but she can also deliver half day & multi-session presentations. Please let us know more about your event and objectives and we will consider whether Dr. Wallace can customize a program to fit your goals.

Does Dr. Wallace work with co-ed and/or male ally groups?

Yes! Dr. Wallace has extensive experience working with male and female audiences, but she specializes in working with teen girls/young women.

Can Dr. Wallace incorporate specific topics into her presentation?

Absolutely. Dr. Wallace can customize presentations to meet the needs of your audience. Additional fees may apply.

What are Dr. Wallace's fees?

Dr. Wallace's fees are customized for each event depending on the specific request, location, length of the presentation, and requirements. Her fee structure includes various options to fit different budgets.

We will provide guidelines and discuss your needs and budget during the initial inquiry phone call. Please note that fees quoted during the inquiry call are only valid for 30 days and the same rate is not guaranteed at a later date. The fees quoted in the Agreement supersede and merge all prior oral or written conversations and understandings and are valid for 14 days from receipt.

What Payment Method Does Dr. Wallace Accept?

Dr. Wallace accepts the following payment methods for speaking events and appearances:

- Corporate, School, College/University check
- PayPal/Zelle
- ACH/Direct Deposit

Can Dr. Wallace Hold an Event Date?

A non-refundable deposit (50% of the speaking fee) is required prior to the event to secure the date, guarantee Dr. Wallace's participation, and release her publicity photos and bio for promotional purposes in association with the scheduled presentation.

If Dr. Wallace is available for your event, the deposit and signed contract should be received 30 business days before the scheduled presentation(s) to allow sufficient time for planning, making travel arrangements, processing, discussing the details of the event, and preparing the customized presentation(s).

I would like to bring Dr. Wallace to speak to my group, but we have a limited budget. Is Dr. Wallace's speaking fee negotiable?

As an educator and community advocate, Dr. Wallace understands that some schools and non-profit groups have tight budgets. We are willing to help you explore creative options for funding her programs.

Can I make an audio, video recording or streaming?
